

Westerly Creek Elementary 2023 Color Run Waiver

Please sign to indicate your agreement of the following:

The Westerly Creek Elementary School (WCE) Color Run is a potentially hazardous activity where colored powder will be thrown at and around me during the event. I understand that some of the course I, the participant, may go through colored corn starch, which has not been tested for chemicals or disease. Participation in the Color Run may involve certain risks not limited to: slips, falls, contact with other participants, negligent acts of other participants, defects or condition of premises or color zones, the effects of the weather including but not limited to high heat, cold temperatures, storms, snow, ice, rain, and/or humidity, and natural risks of insects and wild animals that may be present on the course. Unsecured personal items or property that may be lost, stolen, stained, or damaged at or during the event. Participants under the age of 18 must be supervised by an adult.

Participants are responsible for determining their own physical fitness and/or capacity for the race or activities. It is always advisable, to consult a physician before undertaking any physical activity.

All participants are expected to always exhibit appropriate behavior, including obeying all laws. This includes respect for all people, equipment, and facilities.

All Participants – Waiver & Release of all claims and assumption of risk

ASSUMPTION OF RISK: I acknowledge that there are risks to participants in the “Color Run” as described above, and I voluntarily and knowingly agree to assume the full risk of all injuries, damages, or loss that I may sustain as a result of said participation. I recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs.

RELEASE OF LIABILITY: I agree to waive all claims I may have as a result of participating in these activities and hold harmless Denver Public Schools District, WCE, WCE PTA including its staff, members, officers and employees, the race agents, volunteers, sponsors, and the operators of the venue (“Administrators”). I, release the Administrators from all claims for injuries, including death or incapacity, illnesses, damages, expenses or loss from the race, program or activities.

I agree to indemnify, the Administrators, affiliates, and assigns, from all third-party claims caused in whole or in part by my actions.

Further, I grant permission to WCE PTA and its affiliates and sponsors to use any photographs, motion pictures, recordings, or any other record of this event for any purpose including, but not limited to, promoting, advertising, and marketing purposes.
